The event will be conducted under and in accordance with the CAMS Safe Event Package for Motorkhana and Khanacross, and all competitors are obliged to comply with all reasonable requests of the Organiser. Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at [www.cams.com.au](http://www.cams.com.au). The Organiser reserves the right to refuse any entry in accordance with NCR 83 and to cancel the meeting if, in its opinion, insufficient entries are received. The Organiser reserves the right to cancel, postpone or abandon the event in accordance with NCR 59 of the current CAMS Manual of Motor Sport. Protests must be lodged in accordance with Part XII of the current CAMS Manual of Motor Sport.

<b>Passengers in Vehicles</b>	As per the current NKC Regulation, passengers are not permitted in competing vehicles, except in vehicles driven for the purpose of instruction or guidance.												
<b>Other Regulatory Conditions (Awards, restrictions etc)</b>	Fuel must be in accordance with Schedule G of the current CAMS Manual of Motor Sport. Awards will be provided in accordance with the current VKC Standing Regulations.												
<b>TYRES</b>	<b>Rally, offroad and similar tyres (winter tread, bar-tread, mud-and-snow and hand-cut patterns) are not permitted at the venue; the Chief Scrutineer will be the final arbiter on tyre acceptability</b>												
<b>Penalties</b>	As per section 14 of the National Khanacross Regulations and the Victorian Khanacross Championship standing regulations. <b>Excessive speed or dangerous behavior while not on the competition course or abusive behavior towards officials can be penalized by the competitor being excluded from the meeting.</b>

#### Notes: (nomination of eligible driver category is optional – only one may be chosen)

1. Juniors are defined as having attained the age of 12 years, and being under 18 years of age at the first round of the year.
2. Masters must have attained 60 years of age on the day of the first scheduled VKC round in the year of competition.
3. For Categories J, L and M, a handicap system shall operate based on the class of the competing vehicle. Handicap factors shall be as in 3(b).
4. Drivers are eligible to compete and to gain points in only one class at each round. The chosen class must be nominated on the entry form.
5. Eligible drivers may compete and gain points in a maximum of one category at each round. The chosen category must be nominated on the entry form. Note that a driver who enters a category is also entered in a class and may gain awards and points in both.
6. A driver may be reclassified or recategorised for individual round awards (e.g. trophies) at the discretion of the Clerk of the Course if the driver's nominated class/category has less than 3 entries. This shall not change that driver's class/category for annual awards points.

#### ALCOHOL, DRUGS AND OTHER SUBSTANCES

Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

### COMPETITOR RISK WARNING, DISCLAIMER AND INDEMNITY

**Motor Sport Activities are inherently dangerous recreational activities and there is significant risk of injury, disability or death.**

If you do not wish to be exposed to such risks, then you should not participate in the Motor Sport Activities.

I **acknowledge** that:

- the risks associated with attending or participating in Motor Sport Activities include but are **NOT LIMITED** to the risk that I may suffer harm as a result of:
- motor vehicles (or parts of them) colliding with other motor vehicles or persons or property;
- others participants acting dangerously or with lack of skills;
- high levels of noise exposure;
- acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the event; and
- the failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure my safety.

### EXCLUSION OF LIABILITY, RELEASE & INDEMNITY

In exchange for being able to attend or participate in the Motor Sport Activities, I agree:

- to release CAMS and the Entities to the extent that any or all of them are providing Recreational Services from all liability for:
  - a) my **death**;
  - b) any **physical or mental injury** (including the aggravation, acceleration or recurrence of such an injury);
  - c) the contraction, aggravation or acceleration of a **disease**;
  - d) the coming into existence, the aggravation, acceleration or recurrence of any other **condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs**:
    - i. that is or may be harmful or disadvantageous to me or the community; or
    - ii. that may result in harm or disadvantage to me or the community, howsoever arising from my participation in or attendance at the Motor Sport Activities;
- to indemnify and hold harmless and keep indemnified the Entities to the maximum extent permitted by law in respect of any Claim by any person; and
- to attend at or participate in the Motor Sport Activities at my own risk.
- I understand that:
  - nothing in this document excludes, restricts or modifies any rights that I may have as a result of significant personal injury that is caused by the Reckless Conduct of the Entities as the supplier of the Motor Sport Activities / Recreational Services;
  - nothing in this document prevents the Entities from relying on any laws (including statute and common law) that limit or preclude their liability;
  - nothing in this document excludes any term or guarantee which under statute cannot be excluded; however the liability of the Entities is limited to the minimum liability allowable by law;
  - nothing in this document precludes me from making a claim under a CAMS insurance policy where I am expressly entitled to make a claim under that insurance policy; and
  - CAMS has arranged some limited personal injury insurance coverage which may provide me with some protection for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities. However, I acknowledge and accept that the insurance taken out by CAMS may not provide me with full indemnity for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities, and that I may have to pay the excess if a Claim is made under an insurance policy on my behalf. I agree that my own insurance arrangements are ultimately my responsibility and I will arrange any additional coverage at my expense after taking into account CAMS insurance arrangements, this document and my own circumstances.

**WARNING APPLICABLE IN RELATION TO MOTOR SPORT ACTIVITIES HELD IN VICTORIA - WARNING UNDER THE AUSTRALIAN CONSUMER LAW AND FAIR TRADING ACT 2012:** Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named on this form is required to ensure that the recreational services it supplies to you:

- are rendered with due care and skill;
- are reasonably fit for any purpose which you either expressly or by implication, make known to the supplier; and
- might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22 of the **Australian Consumer Law and Fair Trading Act 2012 (Vic)**, the supplier is entitled to ask you to agree that these conditions do not apply to you.
